



## RANCHO CAMPANA HIGH SCHOOL - SENIOR CONTRACT



Commencement is tentatively scheduled for Wednesday, June 15, 2022 at 1:30 p.m. on the Rancho Campana High School field. This will be a ceremony to honor you, the student, for completing all of the graduation requirements established by the Oxnard Union High School District Board of Education. Participation in the ceremony is contingent upon your successful completion of the required 230 credits and adherence to school regulations for behavior and attendance. Please make every effort to ensure that you are making satisfactory progress towards your graduation requirements. Help us maintain a proper learning environment, and demonstrate respect for all school activities as indicated in the RCHS Student Expectations Handbook 2021-2022 posted on our school website: <https://www.ranchocampanahigh.us/students-parents/student-handbook/>. RCHS and OUHSD rules and policies apply at every school-sponsored event, in-person or online, and the consequences for any violations of those rules and policies are explained in the OUHSD Parent and Student Handbook, which can be found on the OUHSD homepage, [www.oxnardunion.org](http://www.oxnardunion.org).

A great deal of effort goes into planning the graduation ceremony and senior activities. These events are a special occasion for you as a member of the Class of 2022, and also for all of us at RCHS. You are following the standard established by Rancho Campana's first graduating class--one of seriousness, dignity, and pride. To help us continue that tradition and to make the ceremony the meaningful event that parents, faculty, and the graduating class desire, the following must be agreed upon by each senior and his or her parent or guardian:

1. I agree to follow all rules at any school activity, i.e. athletic events, and extracurricular activities. I understand that not doing so will jeopardize my participation in the graduation ceremony. Senior activities are considered school events, which include: Dances, Prom, After Prom, Grad Night, Yearbook Signing date, Senior Activities week and Graduation Practice.
2. I will not consume, distribute, be in possession or be under the influence of any form of alcoholic beverage, drugs or any nicotine product during school or at any school activity. Violation of this provision will automatically exclude me from the graduation ceremony and other senior and school extracurricular events. Other consequences may include suspension or expulsion from school and referral to the appropriate authority.
3. I understand that if I violate school rules that necessitate suspension from school at any time during the school year, I am subject to removal from any or all senior activities, including the graduation ceremony.
4. I understand that if I fail to maintain adequate grades and progress toward graduation, consequences may include loss of free period and removal from all senior activities including Grad Night and the graduation ceremony.
5. I agree that my attendance in all my classes shall conform to school policy. I also understand that any trancies or excessive absences may jeopardize my participation in senior activities and the graduation ceremony.
6. I agree to pay all debts I owe to Rancho Campana High School and turn in all materials as required prior to participating in graduation practice.
7. I agree to wear the cap and gown selected for the ceremony and will adhere to the dress standards for graduation. Mortar boards may be decorated for graduation, however, there are some strict rules about what is allowed. If any mortar board is decorated inappropriately, it will be removed before the graduation ceremony, and you will not be given a replacement. Only the following types of decorations are allowed:
  1. a thank you/appreciation to family, mentors, or teachers
  2. a recognition of the university/college, branch of military, or career you will begin after high schoolMortar boards may only be decorated with marker/paint/tape/gems. Offensive language or images, symbols, sports teams, etc. will not be allowed. If you are in doubt, please consult with a RCHS administrator prior to decorating well in advance of graduation day.
8. I will attend all practices scheduled for the graduation ceremony. I agree to adjust my work schedule and other obligations to meet the practice schedule. In case of illness, I will contact the school administration prior to the practice.
9. I understand that participation in the graduation ceremony is not required to receive my high school diploma. However, should I not attend the graduation ceremony as a result of any violations of this agreement, I understand that a student/parent conference with the principal will be required prior to receiving my diploma.

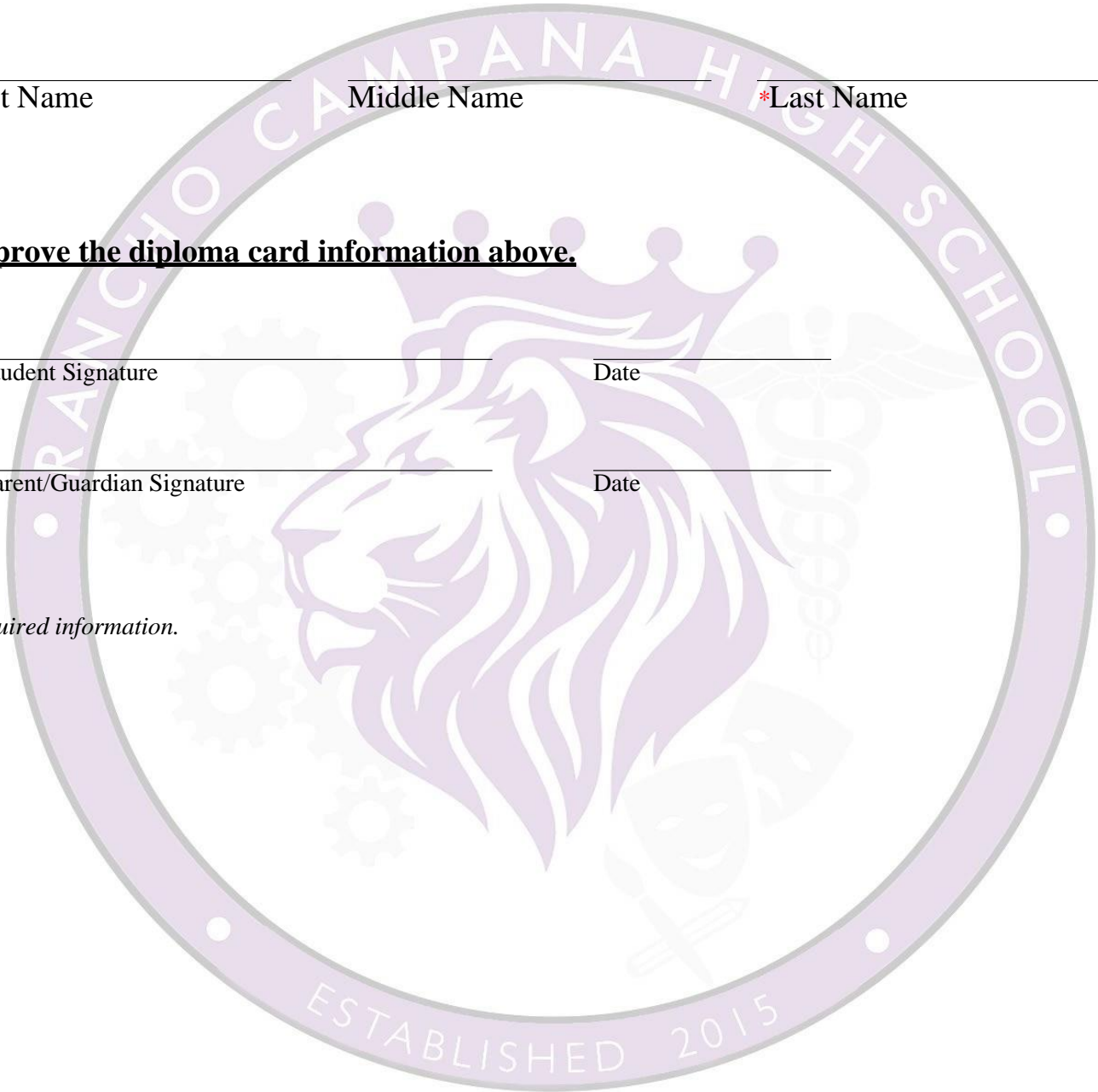
